 - (e) medical certificate issued by a medical practitioner pursuant to Regulation 8 of The Children (Performance) Regulation 1968 (the 1968 Regulations) or as required by the Licensing Authority under Regulation 2 of the 1968 Regulations.
 - (f) where the application is for a licence for an activity, a statement by the child’s parent that the child is medically fit for the proposed activity i.e. sport & modelling.
